



**Absentee Ballot for Special Voting Meeting
To Be Held on January 23, 2019**

**Instructions
for
Non-Registered Voters**

1. You must submit both: (a) an affirmation of eligibility, and (b) a ballot.
2. Complete your ballot and seal it in an unmarked envelope.
3. Fully and legibly execute the affirmation of eligibility.
4. As you are not currently registered to vote in the Village of Briarcliff, you must also have the affirmation **notarized** and enclose a photocopy of one of the following as evidence of your primary residence:
 - a. New York State driver's license, or
 - b. U.S. passport, or
 - c. Other government-issued identification card with your photograph and current address.
5. Enclose your completed and **notarized** affirmation in a sealed envelope, together with the sealed ballot envelope.
6. Write your name and return address on the outer envelope.
7. Mail your absentee ballot envelope to:

8. Your absentee ballot must be received no later than the post office's close of business on Tuesday, January 22, 2019 to be valid. Timely delivery of your fully completed absentee ballot is your responsibility.
9. If more than one absentee ballot is submitted by you, or on your behalf, all such absentee ballots shall thereby be invalidated.
10. You may not vote in person if any absentee ballot has been submitted by you or on your behalf.



**Notarized Affirmation of Eligibility
for
Non-Registered Voters**

I swear or affirm, under of penalty of perjury, that:

I meet all of the following three criteria for eligibility to vote in the special Voting Meeting:

- 1) As of the date of the special Voting Meeting on January 23, 2019, I will have had my primary residence in the Village of Briarcliff Manor for at least thirty (30) days.
- 2) I am at least eighteen (18) years of age.
- 3) I am a U.S. citizen.

As evidence that the address that I have provided below is my current primary address, I have attached a legible photocopy of my current, valid: **[CHECK ONE]**

- New York State Driver's License
- U.S. Passport, or
- Other government-issued identification with my photo and address

Neither I nor any other person has submitted on my behalf any absentee ballot other than this one with respect to the special Voting Meeting. I have voted and sealed this ballot in private and have not allowed any person to observe the marking of this ballot, except for those authorized by state law to do so, including any person serving as a notary public with respect to certifying my signature below. The information that I have provided in this affirmation, including any supporting documents enclosed herewith, is true and complete.
